### **Voting at the meeting**

Pursuant to Clause 69 of the Constitution of our Company, at any general meeting, a resolution put to vote of the meeting shall be decided on a show of hands unless before or on the declaration of the result of the show of hands, a poll is demanded.

In the event of a poll being demanded (and the demand is not subsequently withdrawn), our Share Registrar, Bina Management (M) Sdn. Bhd. will take up the role of our poll administrator, and **the poll will be conducted manually using voting slips**. Such votes shall be counted by the poll administrator, and verified by NeedsBridge Advisory Sdn. Bhd., an independent scrutineer, for the purpose of determining the outcome of the resolutions to be decided on poll at the EGM.

To facilitate the voting procedures, a briefing by the poll administrator will be provided during the EGM before the commencement of the voting session.
